Reference tender notice No. 10(3)/BISP/Admn/09 (Lot 2) published in the newspaper on 11th February, 2012 and posted on PPRA website through tender number TS148893E for purchase of office equipment Punjab/AJK (Lot 1) for Benazir Income Support Programme (BISP). The bids received were opened publicly on 27th February, 2012 at 1200 hours in the presence of representative of bidders. The detail of participating bidders is attached as Annex-I.
