2	M/s Shuja Sons, Islamabad	The firm has not provided Audited balance sheet of last three years along with annual turnover as required under Clause 2.2 of the Pre-qualification Document, therefore declared as non-responsive.
3	M/s Qasim and Ahmad Printers, Islamabad	The firm didn't submit following pre-requisite information/documents along with the pre-qualification application therefore found as non-responsive:- i. Press declaration certificate. ii. Documentary evidence stating at-least five years experience in the relevant field. iii. Detail of resources in terms of machinery & equipment and technical human resource. iv. Audited balance sheet of last three years along with annual turnover of the company. v. Certified proof of financial soundness.
