Bids must be delivered to the above office on or before **1100 hours** on **23rd February, 2015** and must be accompanied by a Bid security as per bid data sheet in shape of a **Bank draft/Call Deposit** in the name of **Director (Procurement), BISP**. A Sealed Bid Box is placed at the reception counter of said premises
7. Bids will be opened in the presence of bidders or their authorized representatives who choose to attend at **1130 hours** on **23rd February, 2015** in the Conference Room, Benazir Income Support Programme, BISP Secretariat, F - Block, Pak. Secretariat, Islamabad.
8. The bidders are requested to give their best and final prices as no negotiations are allowed under the World Bank Procurement Guidelines.
9. The bidders are eligible to bid on "**Lot Basis**". Conditional or incomplete bid will not be accepted.
10. As provided in the Bidding Documents, bidder(s) engaged in corrupt or fraudulent practices (including collusion/polling) will be declared ineligible either indefinitely or for a stated period of time.
