1.10 Core Evaluation Criteria:

Documentary evidence to this effect must be provided with the Bid, which includes copy of contract/purchase order, certificate from client for successful completion of contract, etc.
- c. The bidder must submit National and Sales Tax Numbers' Certificates & Income Tax clearance certificate on the last income Tax Return.
- d. Provided Call Deposit/Demand Draft/Pay Order of Rs. 50,000/- as an earnest money.
