Electronic bidding shall not be permitted. Late bids will not be accepted. Bids will be publicly opened at 1530 hours on the same day, in the presence of the bidders' designated representatives, who choose to attend, in the conference room, Regional Office (AJK), Lower Chattar, Behind AJK Legislative Assembly (Near Bilal Masjid), Muzaffarabad.
