S.R.O. 79(KE)/2019 :

In exercise of the powers conferred by Section 23 of the Benazir Income Support Programme Act 2010 (No. XVIII of 2010), the BISP Board hereby makes the BISP Employees Service Regulations, 2018 as follows:

PART - I - GENERAL

1. Short Title, Applicability and Commencement:

- (1) These Regulations shall be called the, "Benazir Income Support Programme (Employees' Service) Regulations, 2018".
- (2) These Regulations shall come into force at once.

- (3) These Regulations shall apply to all employees of the Programme appointed on regular basis in whole time employment of the Programme; except
- (a) The Chairperson;
 - (b) A person, serving the Programme against a sanctioned post who is appointed on deputation from any Authority (Ministry/Division) or Department (Attached Department) or Autonomous/ Semi-Autonomous/ Regulatory Body/ Authority of the Federal/ Provincial / AJK /GB Government; and
 - (c) A person who is employed by the Programme on contract either against a sanctioned post and/or consultant under whatsoever funding portfolio for a specific period on specific terms.

2. Definitions:

In these Regulations unless the context or the subject otherwise requires:

- (i) "Act" means the Benazir Income Support Programme Act, 2010 (Act No: XVIII of 2010)
- (ii) "Appointing Authority" means a person or an authority authorized by these Regulations to make appointment against a particular post;
- (iii) "Board" means the Board of the Benazir Income Support Programme established under Section 5 of the Act;
- (iv) "Cadre" means the strength of the service or part of the service sanctioned in a separate title/unit;
- (v) "Chairperson" means the Chairperson of the Programme appointed under Sub-Sections (3) and (6) of Section 5 of the Act;
- (vi) "Day" means a Calendar day;
- (vii) "Deputation" means posting of any Civil Servants or an employee of an Autonomous/Semi-Autonomous body of the Federal/ Provincial / AJK /GB Governments, for a specific period, in the Programme on such terms and conditions as may be prescribed; OR as defined in CSR-77;
- (viii) "Director General concerned" means the Director General under whom the employee concerned is serving for the time being or, as the case may be, who is concerned with the administration of the cadre to which the post or, as the case may be, the employee belongs;
- (ix) "Duty" means as defined in Rule 9(6) of the Fundamental Rules & Supplementary Rules;
